#### About the "Enhancing State Response to GBV" project

- TLAC/HBS partnership 2 year project implemented in Gauteng & Western Cape
- Aim of the project: capacitate civil society to hold the state accountable to the implementation of the DVA and SOA
- Components of project
  - Capacity building
  - Research
  - advocacy
- Activities have included:
  - shadow reports,
  - town-hall meetings with local government and community members;
  - awareness raising murals
  - roundtable discussions with MPs, MPL's, parliamentary researchers, CSO

### **Focus on Domestic Violence**

- Research:
  - 51 % of Gauteng women admitted to being victims of DV (Gender Links & MRC, 2010)
    - Only 3.9% of the sample reported the police (Gauteng)
    - 75% men admit to DV (Gauteng)
  - intimate partner violence is the leading cause of women's death, 1 in every 2 women killed is killed by her partner, more than double the rate in the US (MRC femicide study, 2009)
    - 1999 (1<sup>st</sup> study) every 6 hrs a woman is killed by her intimate partner
    - 2009 (follow-up study) every 8 hrs a woman is killed by her intimate partner
- If applying these ratios to female homicides of 2011/2012 it is probable that out of the 2286 women, 1143 were victims of femicide = 95 women murdered every month or 3 women a day!

# **The DVA & Protection Orders**

The Criminal Justice System:

- 1<sup>st</sup> state response to DV was the Prevention of Family Violence Act (1993) the act was limiting however & DV rates unacceptably high
- In 1997, the DOJ estimated that 1 in every 4 women were victims of DV
- In response to limitations and call for overhaul of the PFVA, the DVA was developed by the SA Law Commission & multi-sectoral group
- DVA is impressive but implementation has been problematic in 2009, public hearings on the implementation of the act revealed:
  - non-compliance with DVA by police
  - failure of the police to attend to DV
  - failure to inform victims about their rights
  - "negative", "demeaning" and "discriminatory" attitude of police and court officials
  - Officials ill-equipped to deal with DV
  - Problems accessing courts (during and after-hours)
  - undue delays in court processes
  - lack of privacy in court

## **The DVA & Protection Orders**

- PC and SC on WCPWD made several recommendations to various gvt dpts
- Since the hearings, dpts have made presentations to parliament on progress of implementation
- But do problems persist while the rates of DV continue?
  - 1 in every 4 women is victim (today: 26.6m females in SA, hypothetically = 6.65 million victims of DV)
  - Since the hearings to 2011: 668 865 interim PO's have been applied for (av of 18 579 p/month p/year)
- Objective of TLAC/HBS study was to determine if people continue to experience similar challenges to those raised in 2009 and the impact that problems may cause
